DIRECTIONS: Transfer your answers to the answer sheet and DARKEN the correct answer. If any part of the question is false the entire item is false.

- ( ) 1. Beginning at B's 5 yard line A37 high steps across the goal line holding the ball above his head and pointing skyward with his opposite hand. Touchdown for team A and penalize A37 for unsportsmanlike conduct on the try. (2-9) (10-4-4a) (9-5-1c)
- ( ) 2. Fouls by the opponents of the scoring team on the last timed down of the first half can carry over to the second-half kick-off. (8-2-2)
- ( ) 3. During a two point try A-7 advances to B's 2 yard line and throws an illegal forward pass caught in the end zone by A-81. During the pass an inadvertent whistle is sounded. The try is ended; no points are scored and there will be no replay. (8-3-6)
- ( ) 4. A27 dives for the goal line and the ball hits the pylon. His foot then hits out of bounds at the one half yard line. Ruling: Out of bounds at the one half yard line. (5-1-3a) (1-2-4)(8-2-1)
- ( ) 5. The back judge verifies that team B has 12 players on the field prior to the snap. He should withhold his flag until after the ball is snapped. (9-6-4a) (3-7-2) (3.7.2.C)
- ( ) 6. K83 steps out of bounds to avoid being blocked as he is running down field to cover K's scrimmage kick. K83 does not contact an opponent or the ball after returning inbounds. Ruling: Illegal participation by K83. (9-6-1)
- ( ) 7. A's ball 3rd and nineteen from A's 1 yard line. A-10 is tackled in the end zone but B-60 is called for a 15 yard grasping the face mask foul. Following enforcement it will be A's ball 3rd and five from A's 15 yard line. (10-5-3)
- ( ) 8. Fouls enforced as live-ball fouls by the opponents of the scoring team on the last timed down of the second half cannot carry over to overtime play. (8-2-2)
- ( ) 9. When Team A scores a touchdown during a play when there is no change of possession any team B player fouls committed during the down may be enforced on the try, or on the succeeding kickoff.(8-2-2)
- ( ) 10. The term force is used only in connection with the goal line and in only one direction, i.e., from the field of play into the end zone. When a player applies the force that moves the ball into his teams end zone and the ball becomes dead there in his teams possession, the result is a safety. (8-5-2)(2-13-1)
- ( ) 11. Following a fair catch or awarded fair catch Team A elects to free kick with the use of a punt. This kick could result in a field goal for Team A. (8-4-1a)(2-23-3)(2-23-8)
- ( ) 12. Team A attempts a field goal with the line of scrimmage B's 43 yard line. The kick is short and rolls out of bounds at B's three yard line. It will be Team B's ball, 1st and 10 at the B three yard line. (2-23-4)
- ( ) 13. Following penalty, Team A attempts a kick try from B's 25 yard line. The kick is short and fielded by B-43 at B's 5 yard line. B returns the kick for a touchdown scoring 2 points for Team B. (8-3-2a)

- ( ) 14. Team A attempts a two point try. Team B intercepts their forward pass at the one yard line and returns it for a touchdown. No score-the ball became dead when B gained possession. (8-3-2a)
- ( ) 15. At the snap A-76 and A-68 simultaneously block B-60 on the line of scrimmage within the free blocking zone. A-76's block is at the waist and A-68's block is at the knees. Legal block. (9-3-6 and chart)
- ( ) 16. At the snap A-76 blocks B-60 above the waist and while he is still in contact with B-60, A-68 delays and blocks him at knees. The action was in the free blocking zone. This is an illegal chop block. (9-3-6 and chart)
- ( ) 17. At the snap, outside the free blocking zone, A-88 and A-44 simultaneously block B-55. A-88's block is above the waist and A-44's block is at the knees. This is an illegal chop block. (9-3-2)
- ( ) 18. A-11's forward pass behind the scrimmage is about to be intercepted by B-22 when A-44 bats the ball forward to prevent the interception. Illegal batting by A-44. (9-7-2)
- ( ) 19. A-11's forward pass is batted by B-77 and rebounds back to A-11 who catches it in flight then throws a forward pass to A-88. Illegal forward pass. (7-5-2e)
- ( ) 20. B-51, lying on the ground after being blocked, extends his lower leg a trips ball carrier A-21. This is a personal foul for tripping. (9-3-7)(2-45)
- ( ) 21. When R fouls during a scrimmage kick and the foul is beyond the expanded neutral zone, the basic spot for enforcement of the foul in the spot where the kick ends. (10-4-3)(2-16-2g)
- ( ) 22. When K fouls during a scrimmage kick the basic enforcement spot is the previous spot. (10-4-2b)
- ( ) 23. When R fouls in or behind the expanded neutral zone during a scrimmage kick, the basic spot is the previous spot.(10-4-2b)
- ( ) 24. When B commits an unsportsmanlike foul during a scoring touchdown play by A and there has been no change of possession during the down, Team A may choose to have the penalty enforced on the try or the succeeding kick off. (10-4-5)
- ( ) 25. If the offensive team throws an illegal forward pass from its end zone or commits any other foul for which the penalty is accepted and measurement is from on or behind its goal line, it is a safety. (10-5-4)
