Last night, met with Chad, Frank and Paul to make sure there were no issues with the list. Found out that the CIF required a 1-5 ranking which was not done prior but each group did that today. Board praised Steve Heyman on the hard work and improvement of the ratings program.

Assignor (Caldera)

Reported that we have some crew chiefs and crews that are wanting to be "bought off" by a few coaches. CIF allows individuals to be "bought off" but not the whole crew. Crews want to stay together. Technology is starting to create more activity in this area. Can reassign the officials and have the "by off" monies go to the General Fund is one possible idea for the future.
